

## Authorized Ticketing Providers 25/26 Season

The ticket provider you choose has a huge impact on your brand and the presentation you bring to the stages of the Vancouver Civic Theatres (VCT). Both venue and presenting organization have a common goal of creating an exceptional patron experience and this often starts with the ticket buying process.

This is why the VCT and the City of Vancouver have selected a variety of mandatory pre-qualified **Authorized Ticketing Providers** for our clients' use. As stated in the Theatre License Agreement: ***The Licensee must use one of the authorized ticketing providers designated by Vancouver Civic Theatres for all box office and ticket service requirements in the Theatre.***

This includes an **assignment of proceeds** process; the Authorized Ticketing Provider retains box office sales until post show at which point all VCT venue costs and IATSE 118 technical staff costs are covered and distributed.

The document below outlines the Authorized Ticketing Providers, the service level standards they must meet, as well as the technical and ticketing guidelines that are also found in the VCT Theatre License Agreements.

Please note that the venue agreements must be executed prior to tickets going on sale. Please plan accordingly and allow ample time to organize your event's ticketing process and launch.

### Box Office Service Level Requirements

#### Orpheum and Queen Elizabeth Theatre

- Two box office staff for 1000 or less patrons
- Four box office staff for events of 1000+ patrons
- Provide a minimum of six (6) scanners
- Assigned seating required

#### Vancouver Playhouse

- Two box office staff
- Provide a minimum of three (3) scanners
- Assigned seating recommended, general admission with approval

#### ANNEX

- Box office staff optional
- No scanner required
- Hard tickets accepted –comps and consignment limits apply
- General admission approved

#### Additional service level standard, applicable to all venues

- Box office open a minimum of one and a half hours prior to doors opening
- Box office must have a clear refund policy
- Weekly house counts leading up to the event
- Support mobile or digital tickets
- Ability to support “know before you go” communications to reach patrons

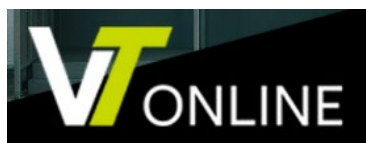

# VCT Venue ticketing requirements

## Facility Fees

*Please refer to annual rate card for up-to-date facility fee rates. This fee is tax inclusive.*

### 2025-2026 season

\$4.00 Registered not for profit organizations per ticket sold \$20.00 and over

\$4.75 Commercial organizations per ticket sold \$20.00 and over

## Complimentary Tickets and Facility Fee

**Complimentary tickets may not exceed 10% of all tickets sold or redeemed for your event.** The Facility Fee will be applied to any complimentary tickets in excess of this amount. All complimentary tickets must have a face value price of \$0.00 on both the patron portion and the theatre portion of the ticket.

## Tickets released for Consignment Sale

**A maximum of 15% of the capacity of the venue**, per performance, may be released by the ticketing agent to the Licensee for consignment sale.

## Form of Ticket

Tickets must consist of a “patron” portion and a “theatre” portion. The Theatre employee will rip the ticket when the patron enters and will keep the “theatre” portion.

- price
- performance
- theatre name
- date
- performance start time
- latecomer's policy
- camera & recording device policy

### Theatre Portion Requirements

- date
- theatre name and address
- section, row, seat

## House seat holds and production mix position needs

Certain seats within the manifest are contractually enforced house holds and additional seats may be required for production needs. ***Please review attached seating maps as reference and consult production about mix position needs.***

The following seats in the Theatres are reserved exclusively for the use of the City and are subject to change:

- 1) **Queen Elizabeth Theatre**: Orchestra Centre, Row 21, Seats 54, 53, 52; Orchestra Centre, Row 15, Seats 41, 42, 43, and 44
- 2) **Vancouver Playhouse Theatre**: Orchestra Centre, Row 16, Seats 36, 35, 34, 33, 32, and 31
- 3) **Orpheum Theatre**: Orchestra Left Centre, Row 21, Seats 28, 29, 30, and 31; Dress Circle Left Centre, Row 4, Seats 128, 129, and 130.
- 4) **ANNEX**: two tickets in bleacher seating; general admission or assigned seats

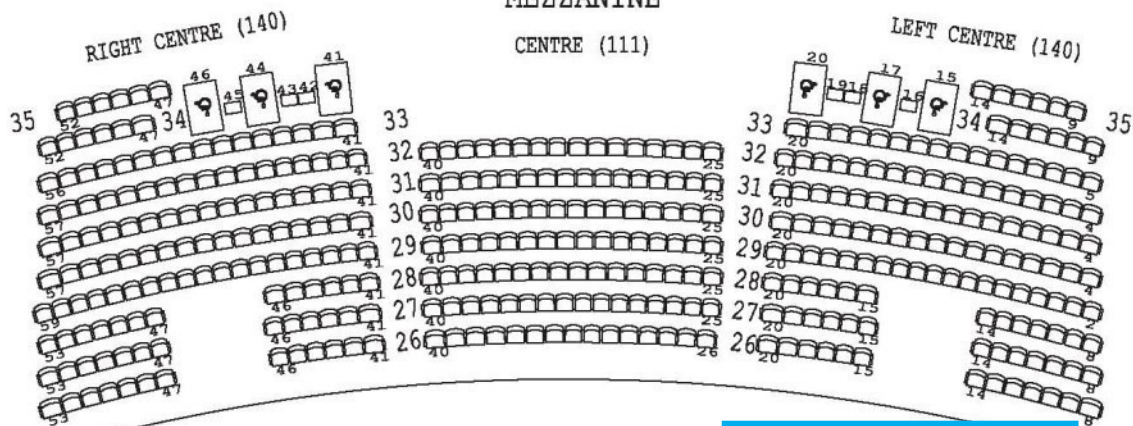

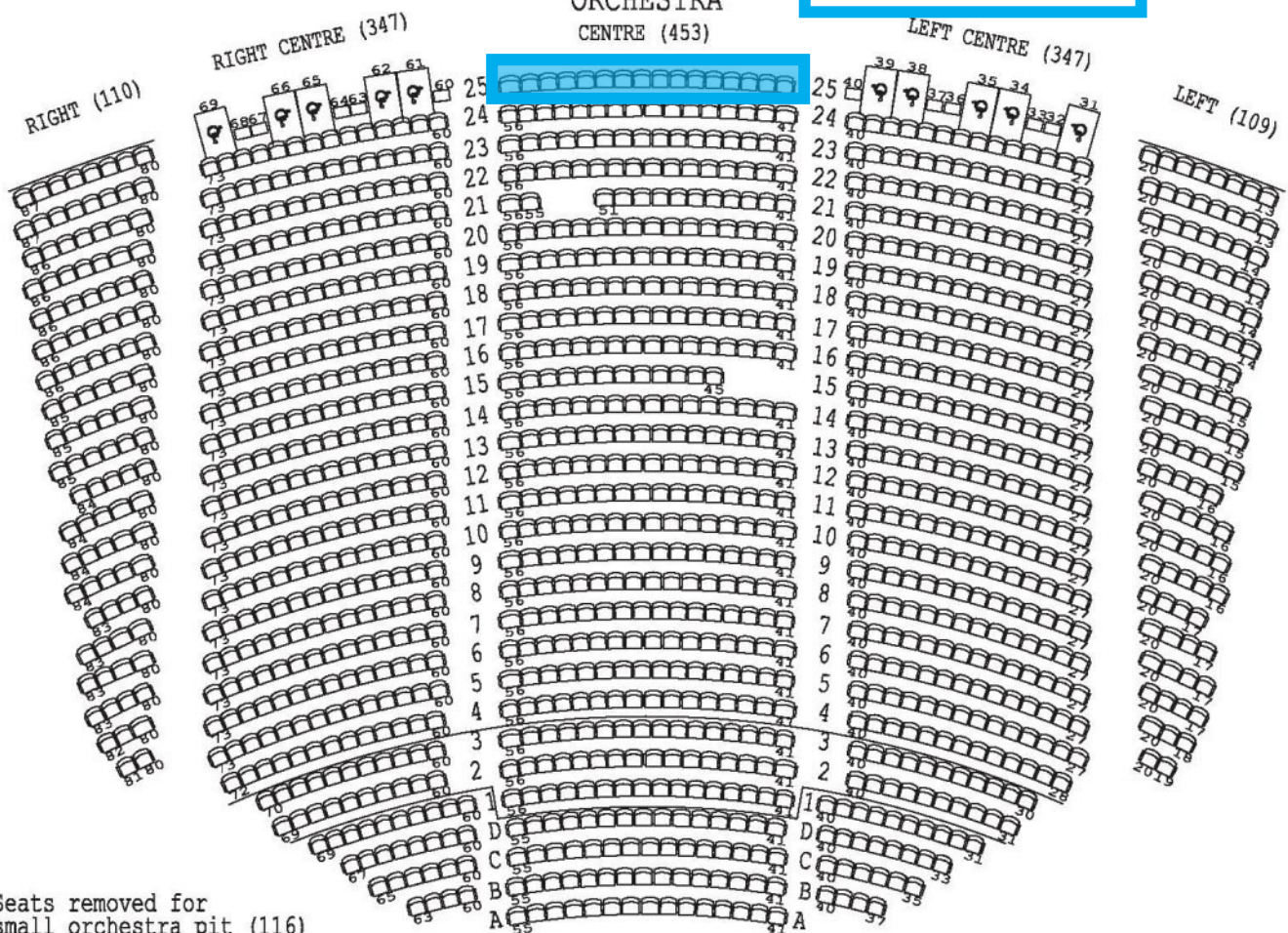

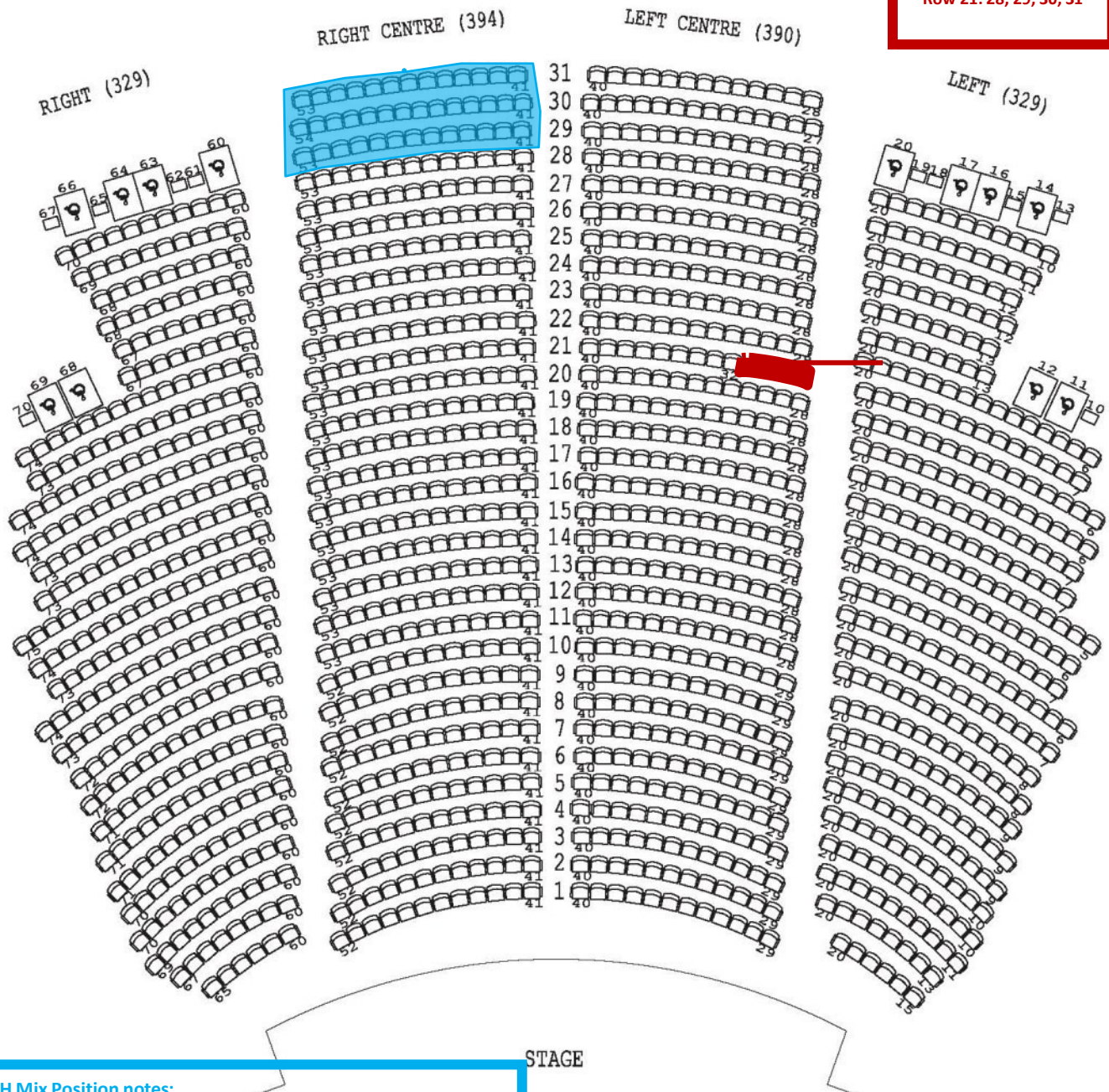
FOH Mix Position

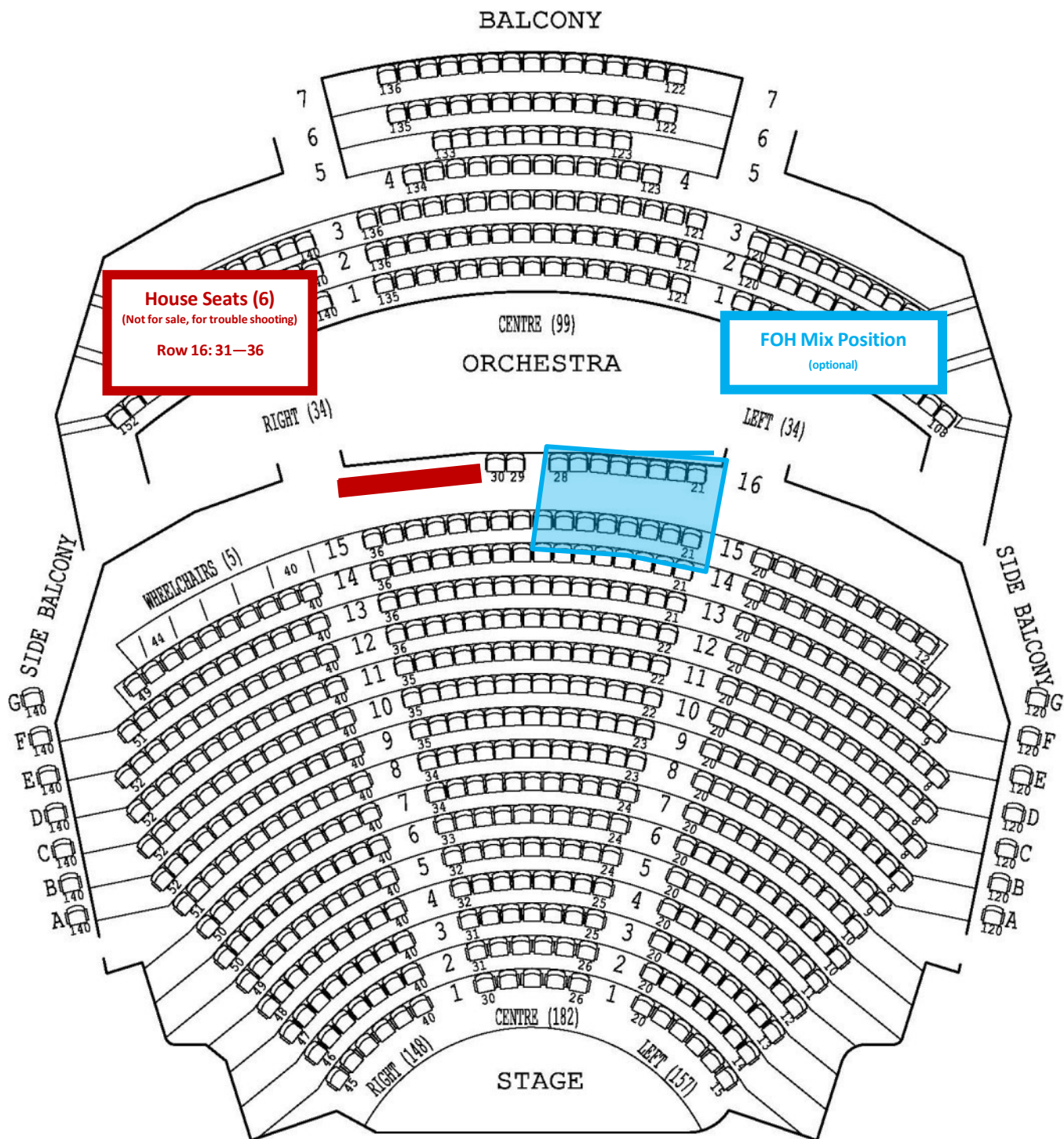

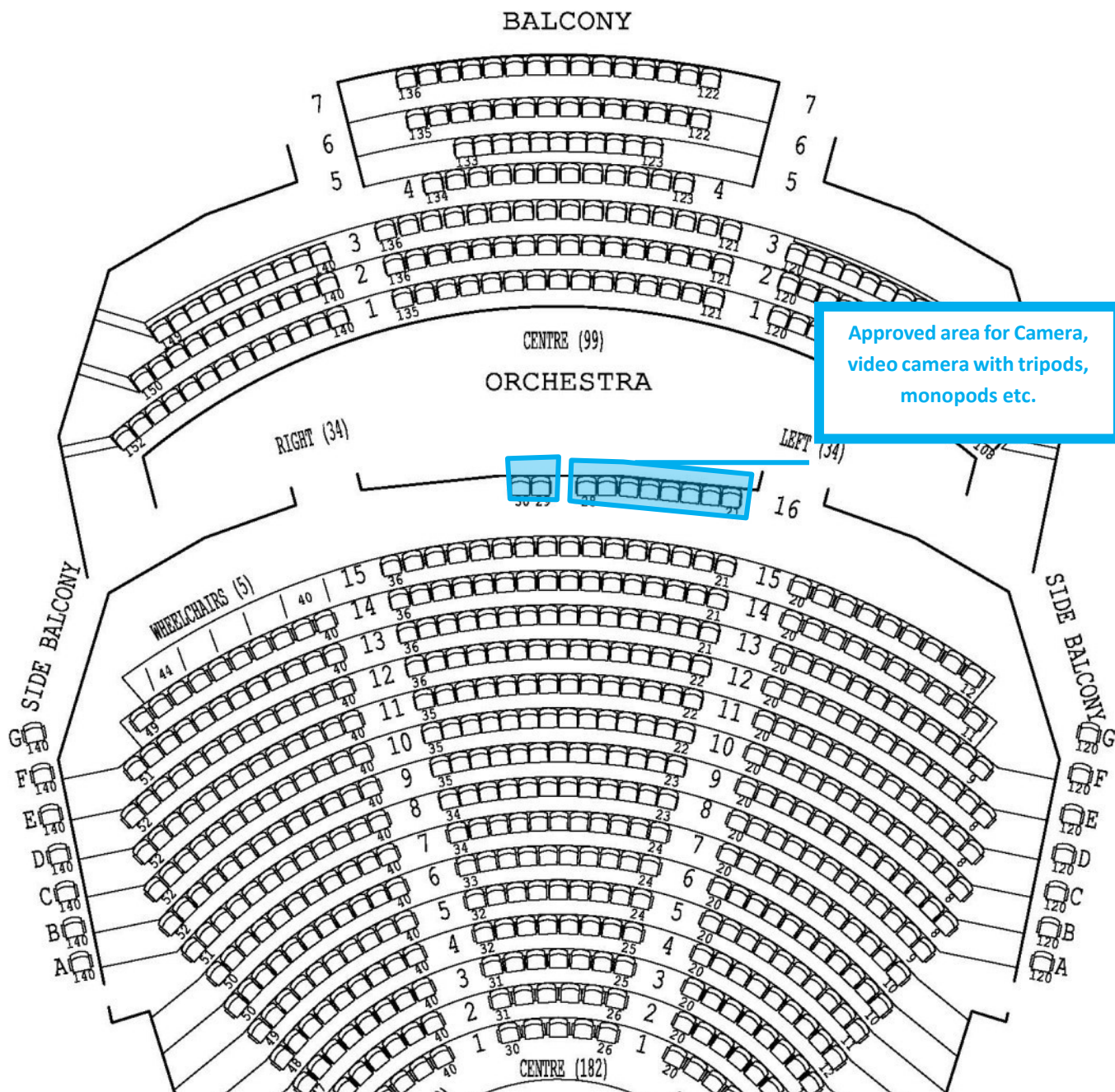
